### **Did you know that we have an Interest Rate Match and/or Bust policy?**

Members, based on the type of loan and pending BCTFCU credit approval, **presenting written documentation of a verifiable loan approval from another financial institution or dealership** with an interest rate **lower than** BCTFCU's loan rate on a similar loan at the time of approval may receive that lower rate minus an additional .25% (with a rate floor of 3.00% when subtracting the additional discount). **NOTE:** BCTFCU will not refinance already existing BCTFCU Loans.

**All Members:** Retired? Resigned? Moved? Married? Congratulations!
